Dear Parents: Most people renting a limousine for their PROM frequently do not realize the responsibility of the CHAUFFEUR not only for their SAFETY but also for the value of the LIMOUSINE.

PROM CONTRACT -In order to provide a pleasant and secure PROM experience, some guidelines are set up below:

1. Absolutely ZERO TOLERANCE for Drinking/Smoking/Drugs, NO Privacy Partition, Moon Roof or any rude behavior.
 2. Absolutely NO ALCOHOLIC Beverages are to be stored or consumed in the limousine - we will check all bags.
 3. We offer FREE WATER, SODA (do not bring yours). Acceptable behavior is expected in the limo, enjoy responsibly.
 4. **If you drink SOME PLACE ELSE you will NOT BE ALLOWED in our limousine, even if you are over 21 year old. Thank you.**
 5. We reserve the right to hold mentioned customer liable for any interior damages or equipment inflected or caused by occupants of said limousine during PROM service, \$500 electronic equipment. Must keep the limousine CLEAN.
 6. Royal Way Limousine, Inc. is not responsible for any lost, stolen, or property left in the limousine at any time.
 7. **Chauffeur will follow the trip itinerary on the contract and limousine will not drive around just because**
 8. **NO CHANGES of this contract are acceptable, ONLY if our ability TO DO SO and at additional CHARGE.**
- ALL PROMS**(booked before APRIL 1st get 1 FREE hour); there is a **total of 100 miles**. Counting Miles will start at pickup. Additional charge for travel time if needed will be added. Each mile thereafter the total is rated at **\$3.00 per mile**.

It is the wish of the management of this limousine service that you have a wonderful time at your **PROM**.

Your chauffeur is a professional with experience. He will assist you with any and all questions you might have.

He will treat you with respect and your obligation is also to treat him/her with total respect.

Your Chauffeur is directed by this management to **TERMINATE the service immediately** (limo will not move and the responsible parent is contacted) if there is any **drinking** of alcoholic beverages, use of illegal drugs, smoking, horseplay or hanging out of the limo window. Money received by **Royal Way Limousine WILL NOT be refunded**.
